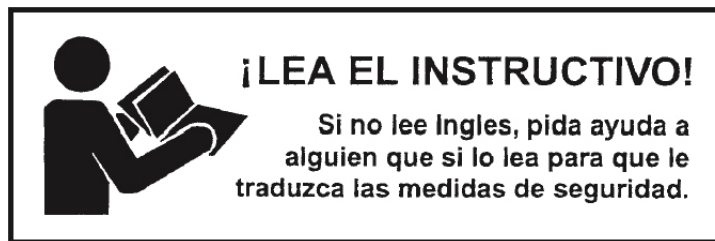

In addition to the design and configuration of equipment, hazard control and accident prevention are dependent upon the awareness, concern, judgement, and proper training of personnel involved in the operation, transport, maintenance and storage of equipment.

It has been said "The best safety device is an informed, careful operator." We ask you to be that kind of operator.

TRAINING

- Safety instructions are important! Read all attachment and power unit manuals; follow all safety rules and safety decal information. (Replacement manuals are available from selling dealer.) Failure to follow instructions or safety rules can result in serious injury or death.
- If you do not understand any part of this manual and need assistance, see your dealer.
- Operators must be instructed in and be capable of the safe operation of the equipment, its attachments, and all controls. Do not allow anyone to operate this equipment without proper instructions.
- Never allow children or untrained persons to operate equipment.
- Train all new personnel and review instruction's frequently with existing workers. A person who has not read and understood all operating and safety instructions is not qualified to operate the machine. An untrained operator exposes himself and bystanders to possible serious injury or death.

PREPARATION

- Always wear relatively tight and belted clothing to avoid getting caught in moving parts. Wear sturdy,

rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head; and respirator or filter mask where appropriate.

- Make sure attachment is properly secured, adjusted, and in good operating condition.
- Power unit, when applicable, must be equipped with ROPS or ROPS cab and seat belt. Keep seat belt securely fastened. Falling off power unit can result in death from being run over or crushed. Keep foldable ROPS system in "locked up" position at all times.
- A minimum 20% of tractor and equipment weight must be on the tractor front wheels when attachments are in transport position. Without this weight, tractor could tip over, causing personal injury or death. The weight may be attained with a loader, front wheel weights, ballast in tires or front tractor weights. Weigh the tractor and equipment. Do not estimate.

TRANSPORTATION

- Always comply with all state and local laws governing highway safety and lighting and marking requirements.
- Never allow riders on power unit or attachment.
- Do not operate or transport on steep slopes.
- Use extreme care and reduce ground speed on slopes and rough terrain.
- Do not operate or transport equipment while under the influence of alcohol or drugs. Consult your doctor about operating this machine while taking prescription medications.

OPERATION

- Never go underneath equipment (lowered to the ground or raised) unless it is properly blocked and secured. Never place any part of

the body underneath equipment or between moveable parts even when the engine has been turned off. Hydraulic system leak down, hydraulic system failures, mechanical failures, or movement of control levers can cause equipment to drop or rotate unexpectedly and cause severe injury or death.

- Always comply with all state and local laws governing highway safety and lighting and marking requirements.
- Operate only in daylight or good artificial light.
- Keep bystanders away from equipment.
- Keep hands, feet, hair, and clothing away from equipment while engine is running. Stay clear of all moving parts.
- Power unit, when applicable, must be equipped with ROPS or ROPS cab and seat belt. Keep seat belt securely fastened. Falling off power unit can result in death from being run over or crushed. Keep foldable ROPS system in “locked up” position at all times.
- Never allow riders on power unit or attachment.
- Always sit in power unit seat when operating controls or starting engine. Securely fasten seat belt, place transmission in neutral, engage brake, and ensure all other controls are disengaged before starting power unit engine.
- Look down and to the rear and make sure area is clear before operating in reverse.
- Use extreme care when working close to fences, ditches, other obstructions, or on hillsides.
- Do not operate or transport on steep slopes.
- Do not stop, start, or change directions suddenly on slopes. Always operate down slopes;

never across the face.

- Use extreme care and reduce ground speed on slopes and rough terrain.
- Keep alert and watch the front as well as the rear when operating.
- Stop power unit and equipment immediately upon striking an obstruction. Turn off engine, remove key, inspect, and repair any damage before resuming operation.
- Before leaving operator’s seat, put attachment on the ground. Engage brake, stop engine, remove key, and remove seat belt.

MAINTENANCE

- Always wear relatively tight and belted clothing to avoid getting caught in moving parts. Wear sturdy, rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head; and respirator or filter mask where appropriate.
- Never go underneath equipment (lowered to the ground or raised) unless it is properly blocked and secured. Never place any part of the body underneath equipment or between moveable parts even when the engine has been turned off. Hydraulic system leak down, hydraulic system failures, mechanical failures, or movement of control levers can cause equipment to drop or rotate unexpectedly and cause severe injury or death.
- When performing maintenance or repairs make sure the equipment is in the lowered position. Failure to do so can cause serious injury or death.

MAINTENANCE(cont'd)

- Make sure attachment is properly secured, adjusted, and in good operating condition.
- Before leaving operator's seat put attachment on the ground. Engage brake, stop engine, remove key, and remove seat belt.
- Never perform service or maintenance with engine running.
- Keep all persons away from operator control

area while performing adjustments, service, or maintenance.

- Tighten all bolts, nuts, and screws to torque chart specifications. Check that all cotter pins are installed securely to ensure equipment is in a safe condition before putting unit into service.

STORAGE

- Block equipment securely for storage.
- Keep children and bystanders away from storage area.

DEALER INSTRUCTIONS

Dealer Checklist

(Dealer's Responsibility)

Inspect the equipment thoroughly after assembly to be certain it is set up properly before delivering it to the customer. The following check list is a reminder of points to inspect.

Check off each item if it is found satisfactory or after proper adjustment is made.

____ Check that all safety decals are installed and in good condition. Replace if damaged.

____ Check all bolts to be sure they are tight.

____ Check that all cotter pins and safety pins are properly installed.

____ It is important for the dealer to visually check and make sure all parts are in tact prior to delivery to customer.

____ Show customer the safe, proper procedures to be used when mounting, dismounting, and storing equipment.

____ Show customer how to make adjustments.

____ Present Owner's/Operator's Manual and request that customer and all operators read it before operating equipment. Point out the manual safety rules, explain their meanings and emphasize the increased safety hazards that

exist when safety rules are not followed.

____ Point out the safety decals. Explain their meaning and the need to keep them in place and in good condition. Emphasize the increased safety hazards when instructions are not followed.

____ Explain to customer the potential crushing hazards of going underneath raised equipment. Instruct customer that service work does not require going underneath unit and never to do so.

____ Complete the Warranty Registration located on page 16 and mail to Tufline.

Operation

The ATV BOX SCRAPER is designed to be for all-terrain utility vehicles and lawn and garden tractors only. Do not over heat power source. Make sure your vehicle has adequate power and is capable of pulling this implement.

Safety is a primary concern in the design and manufacture of our products. Unfortunately, our efforts to provide safe equipment can be wiped out by an operator's single careless act.

In addition to the design and configuration of equipment, hazard control and accident prevention are dependent upon the awareness, concern, judgement, and proper training of personnel involved in the operation, transport, maintenance and storage of equipment.

It has been said "The best safety device is an informed, careful operator." We ask you to be that kind of operator.

The operator is responsible for the safe operation of this equipment. The operator must be properly trained. Operators should be familiar with the equipment, the power unit, and all safety practices before starting operation. Read the safety rules and safety decals on pages 2-6.

Owner should check and tighten all hardware after the first hour of operation. The break in stage of your new ATV BOX SCRAPER can cause minimal loosening of hardware. Please see Bolt Torque Chart (page 10) for proper torque information.

WARNING

- Always comply with all state and local laws governing highway safety and lighting and marking requirements.
- Never allow riders on power unit or attachment.
- Do not operate or transport on steep slopes.
- Use extreme care and reduce ground speed on slopes and rough terrain.
- Do not operate or transport equipment while under the influence of alcohol or drugs. Consult your doctor about operating this machine while taking prescription medications.
- Before connecting the ATV BOX SCRAPER be sure your power unit has a 1 7/8" ball connection. Make sure the ball coupler fully locks.
- When connecting the ATV BOX SCRAPER to your power unit use caution and back up at a slow rate of speed. Keep bystanders clear of the utility vehicle and land plane.
- This unit is not recommended to be pulled behind ATV's with engines less than 450cc.
- This unit is not recommended to be pulled by ATV's with air-cooled automatic transmissions.
- Scraping should be done at slow speeds and in low gear only.
- Fully tighten all nuts and bolts prior to each operation, use the torque chart for reference.
- Transport wheels are used for unit transport and as a depth control gauge when needed. If cutting in soft ground lower wheels to keep unit from digging in too deep and causing too much stress on the power source.
- Do not add weight to the ATV BOX SCRAPER series implement. Added weight may cause stress to the power source and cause major damage to the vehicle.

Owner Service

WARNING

- **NEVER GO UNDERNEATH EQUIPMENT.** Never place any part of the body underneath equipment or between moveable parts even when the engine has been turned off. The information in this section is written for operators who possess basic mechanical skills. If you need help, your dealer has trained service technicians available. For your protection, read and follow the safety information in this manual.

WARNING

- Keep all persons away from operator control area while performing adjustments, service, or maintenance.

- Before dismounting power unit or performing any service or maintenance, follow these steps: disengage power to equipment, lower all raised components to the ground, set parking brake, stop engine, remove key, and unfasten seat belt.

CAUTION

- Always wear relatively tight and belted clothing to avoid entanglement in moving parts. Wear sturdy, rough-soled work shoes and protective equipment for eyes, hair, hands, hearing, and head.

Check all nuts for proper torque periodically. Please see bolt torque chart (page 10) for proper torque information.

Storage

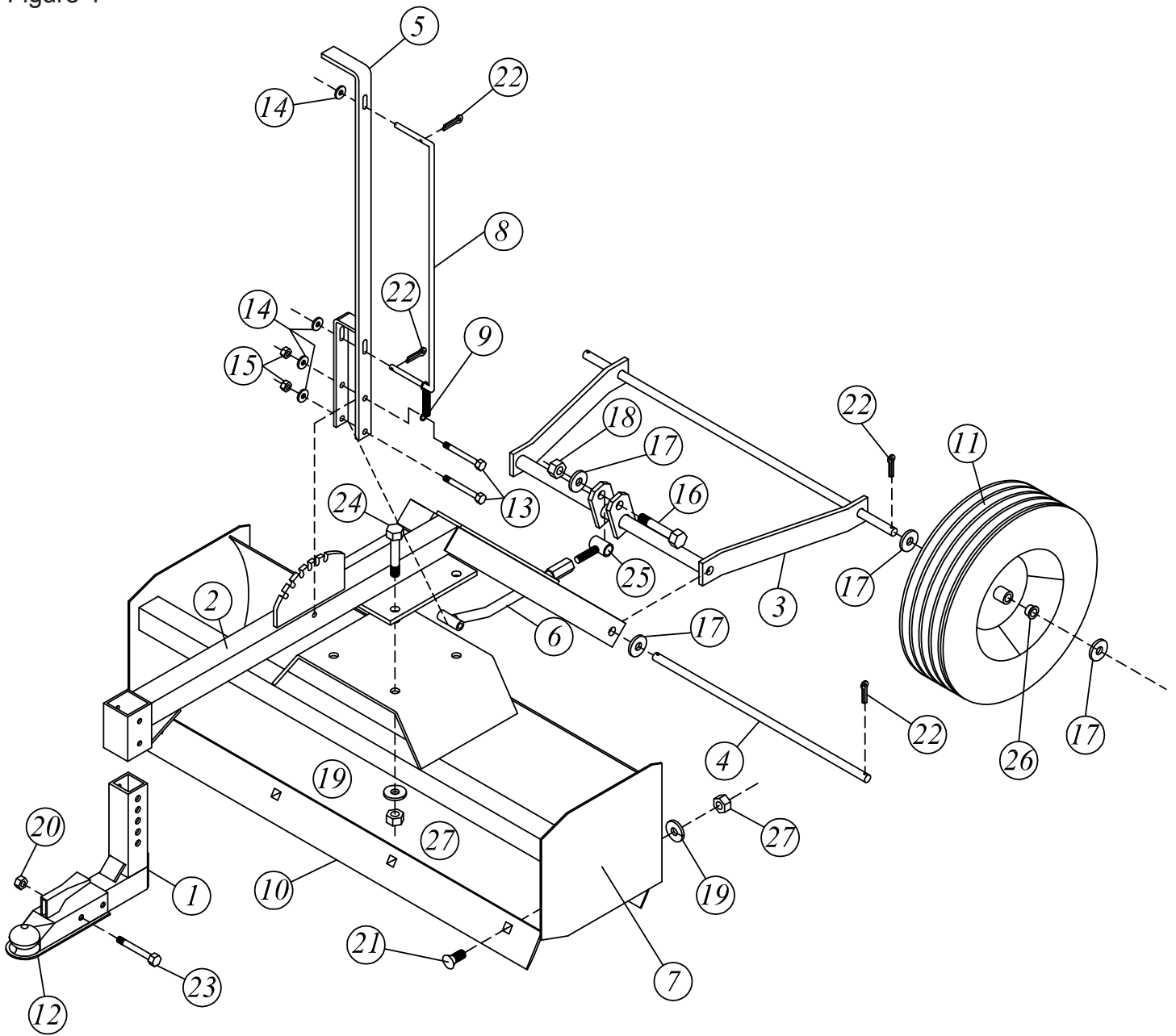
When storing your ATV BOX SCRAPER make sure the unit is placed on level ground and clear of any obstructions. Use caution when disconnecting the box scraper from your utility vehicle.

Under no circumstances will this Warranty apply in the event that the product, in the good faith opinion of Monroe-Tufline, has been subjected to improper operation, improper maintenance, misuse, or an accident. This Warranty does not apply in the event that the product has been materially modified or repaired by someone other than Monroe-Tufline, a Monroe-Tufline authorized dealer or distributor, and/or a Monroe-Tufline authorized service center. This Warranty does not cover normal wear or tear, or normal maintenance items. This Warranty also does not cover repairs made with parts other than those obtainable through Monroe-Tufline.

This Warranty is extended solely to the original purchaser of the product. Should the original purchaser sell or otherwise transfer this product to a third party, this Warranty does not transfer to the third party purchaser in any way. There are no third party beneficiaries of this Warranty.

Monroe-Tufline makes no warranty, express or implied, with respect to cutting edges, shanks, tires or other parts or accessories not manufactured by Monroe-Tufline. Warranties for these items, if any, are provided separately by their respective manufacturers.

Monroe-Tufline's obligation under this Warranty is limited to, at Monroe-Tufline's option, the repair or replacement, free of charge, of the product if Monroe-Tufline, in its sole discretion, deems it to be defective or in noncompliance with this Warranty. Such parts shall be provided by the selling dealer to the user during regular working hours. **If requested, the product must be returned to Monroe-Tufline with proof of purchase within thirty (30) days after such defect or noncompliance is discovered or should have been discovered, routed through the dealer and distributor from whom the purchase was made, transportation charges prepaid.** Monroe-Tufline shall complete such repair or replacement within a reasonable time after Monroe-Tufline receives the product. THERE ARE NO OTHER REMEDIES UNDER THIS WARRANTY. THE REMEDY OF REPAIR OR REPLACEMENT IS THE SOLE AND EXCLUSIVE REMEDY UNDER THIS WARRANTY.
