Weigh the tractor and equipment. Do not estimate.

- Power unit, when applicable, must be equipped with ROPS or ROPS cab and seat belt. Keep seat belt securely fastened. Falling off power unit can result in death from being run over or crushed. Keep foldable ROPS system in "locked up" position at all times.
- Never allow riders on power unit or attachment.
- Always sit in power unit seat when operating controls or starting engine. Securely fasten seat belt, place transmission in neutral, engage brake, and ensure all other controls are disengaged before starting power unit engine.
- Look down and to the rear and make sure area is clear before operating in reverse.
- Use extreme care when working close to fences, ditches, other obstructions, or on hillsides.
- Do not operate or transport on steep slopes.
- Do not stop, start, or change directions suddenly on slopes. Always operate down slopes;

never across the face.

- Use extreme care and reduce ground speed on slopes and rough terrain.
- Keep alert and watch the front as well as the rear when operating.
- Stop power unit and equipment immediately upon striking an obstruction. Turn off engine, remove key, inspect, and repair any damage before resuming operation.
- Before leaving operator's seat, put attachment on the ground. Engage brake, stop engine, remove key, and remove seat belt.

Never place any part of the body underneath equipment or between moveable parts even when the engine has been turned off. ### **DEALER INSTRUCTIONS**

#### **Dealer Checklist**

(Dealer's Responsibility)

Inspect the equipment thoroughly after assembly to be certain it is set up properly before delivering it to the customer. The following check list is a reminder of points to inspect.

Check off each item if it is found satisfactory or
after proper adjustment is made.
Check that all safety decals are installed
and in good condition. Replace if damaged.
Check all bolts to be sure they are tight.
Check that all cotter pins and safety pins
are properly installed.
It is important for the dealer to visually
check and make sure all parts are in tact prior to
delivery to customer.
Show customer the safe, proper proce-
dures to be used when mounting, dismounting,
and storing equipment.
Show customer how to make adjust-
ments.
Present Owner's/Operator's Manual and
request that customer and all operators read it
before operating equipment. Point out the man-
ual safety rules, explain their meanings and
emphasize the increased safety hazards that

exist when safety rules are not followed.
Point out the safety decals. Explain their
meaning and the need to keep them in place
and in good condition. Emphasize the increased
safety hazards when instructions are not fol-
lowed.
Explain to customer the potential crushing
hazards of going underneath raised equipment.
Instruct customer that service work does not
require going underneath unit and never to do
SO.
Complete the Warranty Registration
located on page 16 and mail to Tufline.

### **Operation**

The ATV BOX SCRAPER is designed to be for all-terrain utility vehicles and lawn and garden tractors only. Do not over heat power source. Make sure your vehicle has adequate power and is capable of pulling this implement.

Safety is a primary concern in the design and manufacture of our products. Unfortunately, our efforts to provide safe equipment can be wiped out by an operator's single careless act.

In addition to the design and configuration of equipment, hazard control and accident prevention are dependent upon the awareness, concern, judgement, and proper training of personnel involved in the operation, transport, maintenance and storage of equipment.

It has been said "The best safety device is an informed, careful operator." We ask you to be that kind of operator.

The operator is responsible for the safe operation of this equipment. The operator must be properly trained. Operators should be familiar with the equipment, the power unit, and all safety practices before starting operation. Read the safety rules and safety decals on pages 2-6.

Owner should check and tighten all hardware after the first hour of operation. The break in stage of your new ATV BOX SCRAPER can cause minimal loosening of hardware. Please see Bolt Torque Chart (page 10) for proper torque information.

### **A** WARNING

- Before connecting the ATV BOX SCRAPER be sure your power unit has a 1 7/8" ball connection. Make sure the ball coupler fully locks.
- When connecting the ATV BOX SCRAPER to your power unit use caution and back up at a slow rate of speed. Keep bystanders clear of the utility vehicle and land plane.

- This unit is not recommended to be pulled behind ATV's with engines less than 450cc.
- This unit in not recommended to be pulled by ATV's with air-cooled automatic transmissions.
- Scraping should be done at slow speeds and in low gear only.
- Fully tighten all nuts and bolts prior to each operation, use the torque chart for reference.
- Transport wheels are used for unit transport and as a depth control gauge when needed. If cutting in soft ground lower wheels to keep unit from digging in too deep and causing too much stress on the power source.
- Do not add weight to the ATV BOX SCRAPER series implement. Added weight may cause stress to the power source and cause major damage to the vehicle.

#### **Storage**



Monroe-Tufline makes no warranty, express or implied, with respect to cutting edges, shanks, tires or other parts or accessories not manufactured by Monroe-Tufline. Warranties for these items, if any, are provided separately by their respective manufacturers.

Monroe-Tufline's obligation under this Warranty is limited to, at Monroe-Tufline's option, the repair or replacement, free of charge, of the product if Monroe-Tufline, in its sole discretion, deems it to be defective or in noncompliance with this Warranty. Such parts shall be provided by the selling dealer to the user during regular working hours. If requested, the product must be returned to Monroe-Tufline with proof of purchase within thirty (30) days after such defect or noncompliance is discovered or should have been discovered, routed through the dealer and distributor from whom the purchase was made, transportation charges prepaid. This Warranty is subject to any existing conditions of supply which may directly affect Monroe-Tufline's ability to obtain materials or manufacture replacement parts.

No agent, representative, dealer, distributor, service person, salesperson, or employee of any company, including without limitation, Monroe-Tufline, its authorized dealers, distributors, and service centers, is authorized to alter, modify, or enlarge this Warranty.
